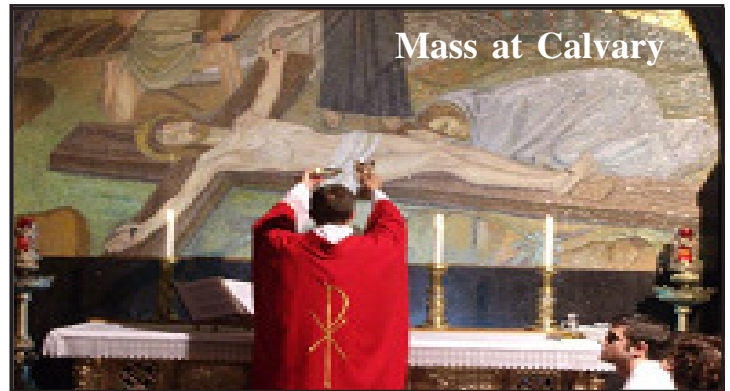

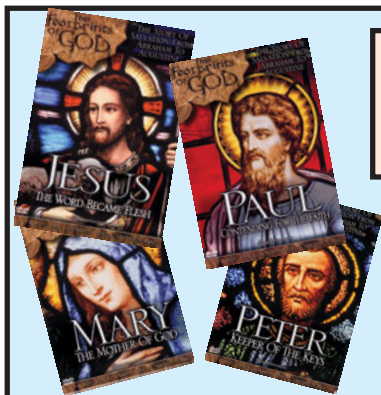

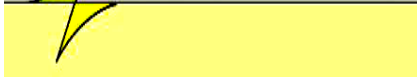

## The Holy Land Itinerary\*

**Day 1** Departure from the United States.

**Day 2** Arrival in Tel Aviv's modern **Ben Gurion Airport** and transfer to **Galilee**. Dinner then evening **Mass** at the **Primacy of Peter Church** on the



Mount of Beatitudes

**Sea of Galilee**. Steve will give a short talk on the shore, then overnight in **Tiberias**.

**Day 3** Ascend the **Mount of Transfiguration** (Mt. Tabor) early to miss the crowds; then to **Wedding Church** in **Cana** for Renewal of Wedding Vows. After lunch Visit **Nazareth**, especially the **Church of Annunciation** for **Mass** at the **Grotto of Annunciation**. Visit **House of the Holy Family**. Dinner and overnight in **Tiberias**.

**Day 4** **Mount of Beatitudes** for **Mass**. On to **Caesarea Philippi**. Drive through **Golan Heights**; view the **Syrian border**. Visit **Tabgha** where Jesus multiplied loaves and fishes. Dinner at **Aberge Shulamit**. Overnight in **Tiberias**.

**Day 5** Visit the **Ancient "Jesus Boat"** then boat ride on **Sea of Galilee**. Drive to **Capernaum** for **Mass** at **St. Peter's House** and the **synagogue** where Jesus said "Eat My Flesh!" Renew **Baptismal Vows** in the **Jordan River**. Drive through the **Jordan Valley** to **Jerusalem** and just before we get there we stop at **Ein Karem** to visit the **Church of the Visitation**. Dinner and overnight in **Jerusalem**.

**Day 6** **High Mass** at the **Tomb of Christ** in the **Church of the Holy Sepulchre**. After breakfast drive to **Bethlehem** for shopping. Visit **Shepherd's Field**, **Church of the Nativity** where Jesus was born. Back to Jerusalem to visit **Temple Model** and **Shrine of the Book** at the **Israel Museum**. Steve's talk on the Israeli-Palestinian situation. Dinner and overnight in **Jerusalem**.

**Day 7** Drive to the **Mt. of Olives** to visit the **Church of Pater Noster**. Palm Sunday procession to **Dominos Flevit** where Jesus wept and further down the mountain to the **Garden of Gethsemane** for **Mass**. **Promenade** scenic view and lunch. Drive to **Mt. Zion** to visit the **Church of the Dormition** and the **Upper Room** ending at the **Church of St. Peter in Gallicantu**. Dinner and overnight in **Jerusalem**.

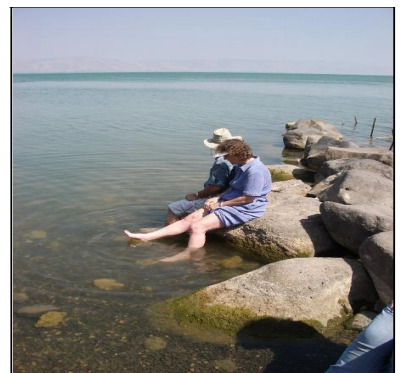

**Day 8** Carry crosses along the **Via Dolorosa** arriving for **Mass** at the **Church of the Holy Sepulchre**, then breakfast. Visit the **Church of St. Anne** where Mary was born and the **Pools of Bethesda**. Enter through the **Dung Gate** to pray at the **Western Wall**. **Free afternoon**. Optional tour of the **Shroud of Turin Exhibit** and extra shopping. **Farewell dinner** in **Bethlehem**. Overnight in **Jerusalem**.

**Day 9** **Free day** for shopping, prayer, rest, or optional side trips. We offer an Optional Excursion (tour escort will advise price) to **Qumran**, **Masada**, **Jericho** and swimming in the **Dead Sea**. We also have **Sammie the Camel** ready to give you a ride. **Mass** at **Notre Dame Chapel** and dinner. Blessing of all the Rosaries and other religious items. This evening pack and get ready for flight through the night back home.

**PAYMENT:** In order to meet deposit schedules with suppliers for this tour, Corporate Travel Service asks for prompt payment on the requested dates. Please see the reservation form for the payment schedule. The advertised price is based on 100 passengers, tariffs, exchange rates, air line fuel surcharges and taxes in effect when the tour was organized and are subject to increase before tour departure. Price of the tour may have to be adjusted before final payment to reflect any increase in tariffs, fluctuation in exchange rates and/or fuel surcharges. Corporate Travel Service accepts cash, check, money orders and Visa and MasterCard for payment. **Note: In order to qualify for the cash discount price, traveler must pay all installments by cash or check. Cash discount will be taken at the time final payment is made.**

**CANCELLATION POLICY:** All cancellations must be received in writing. Cancellations received between time of deposit and December 12, 2010 will forfeit \$200 per person. Forfeit \$350 deposit between December 12, 2010 and January 31, 2011. Forfeit \$1600 for cancellations received between January 31, 2011 and February 25, 2011. After February 25, 2011, no refund. **Penalties will be according to the fax or postmark date.**

**STATE DEPARTMENT & OTHER AGENCIES:** From time to time the State Department ([www.state.gov](http://www.state.gov)) and the Centers for Disease Control ([www.cdc.gov](http://www.cdc.gov)) and other government agencies and departments issue travel advisories or warnings for one or more of the destinations that you may be visiting on tour. **ROOMS:** Tour prices are per person according to a room type: a "Single" room is one person in a room and a "Double" is two persons in one room. "Triple" rooms are discouraged because of cramped quarters. Triples are one double bed with two persons sharing the bed and one single bed. Triples are not always available. Single rooms are limited in Israel and are available first come-first served until the supply is exhausted.

**CHECKED LUGGAGE:** Checked baggage is limited to one bag per person. There can be no exceptions. For most airlines, the one checked bag is limited to **50 pounds and 62 inches** (length + width + height). If these specifications are exceeded, excess charges may be collected by the airline at the airport. Do not lock baggage you intend to check in at the airport. Please confirm these specifications when you receive your final travel documents, as they can and do change.

**NOTE: Airlines are expected to begin charging for International checked baggage. You will be notified in your final travel documents and such costs will be the responsibility of the traveler.**

**CARRY ON LUGGAGE:** You may also bring a small carry-on bag that will fit under an airline seat and on the small parcel racks of the motor coach, which average about 8 inches high by 18 inches deep. It is best if your carry-on bag is soft sided,

as the parcel racks on the motor coaches are small. Currently, travellers are allowed to transport only small amounts of liquids, gels, lotions, aerosols or similar items on their person or in their carry-on luggage. Details will be in your final travel documents.

**GRATUITIES:** Gratuities for your escort, driver and guides are included.

**PASSPORT:** A valid U.S. Passport is required of all passengers. Please apply for your passport immediately as passports are taking a long time to process. Make sure to have it in your possession at all times while on tour. **It must be valid for 6 months following the return date of the trip or boarding may be denied or entry into the destination may be forbidden.**

**GROUP AIR:** Due to the airlines' reduced capacity and restrictive group reservation terms, group air reservations are often difficult to coordinate. The number of connections, length of layovers, and all conditions surrounding air travel cannot be guaranteed and may change before departure. Accordingly, if you require specific air travel needs and are not flexible concerning group air travel, **you may wish to consider purchasing a Land-Only package** and secure your own preferred air arrangements. In this case, you must notify Corporate Travel Service no less than 120 days before departure, be responsible for meeting the group at a specified location and time on the tour, and sign a Corporate Travel Service Land Only Waiver. Land only passengers are responsible for arranging and the cost of transfers to and from the airport. If you require specific seats, Corporate Travel Service suggests you book the tour package as "land only" and arrange your own air.

**DOMESTIC AIR TO NEW YORK:** You are responsible for your own air arrangements to New York. You will be notified of the international gateway airport (JFK or EWR) about 60 days prior to departure. **Do not buy domestic air before hand.**

**TRAVEL DOCUMENTS:** Unless otherwise notified, Corporate Travel Service will mail to you or your group leader a more detailed itinerary and General Information Sheet approximately 2 weeks or 10 days before departure.

**HEALTH REQUIREMENTS:** Travellers must be medically and physically fit for this tour. This tour requires significant walking, as motor coaches are not permitted to pick up and drop off in front of major attractions. The tour is not wheelchair accessible. Any special medical conditions or equipment must be advised in writing, for evaluation of feasibility, at the time of making your reservation.

**CHILDREN UNDER 18:** For a minor under the age of 18 to travel out of the United States without both parents or legal guardians, a notarized affidavit must be obtained and presented to immigration official upon departure and return to the United States. You may request a form from our office. *Children must be at least 6 years old to travel.*
